SUBJECT: Self Help for the Elderly

RECOMMENDATION

Discuss the informational presentation made by Self Help for the Elderly at the November 17, 2015 Senior Commission meeting, and review/edit/approve a draft letter to the City Council with the Commission's observations on Self Help for the Elderly's services.

BACKGROUND

At the November 17, 2014 Senior Commission meeting, Self Help for the Elderly gave an informational presentation on its services. At the January 12, 2015 Senior Commission meeting, Commissioner Lew initiated a discussion about the presentation, and a desire to communicate with the City Council about it. The consensus of the Senior Commission was to transmit a letter to the City Council communicating its perspective that Self Help is a valuable service provider, and noting the large contingent of patrons and supporters that attended the November meeting.

Staff indicated that it would confirm with the City Attorney whether it would be appropriate to send a letter based upon that discussion, and draft a letter. The City Attorney indicated that because the item was not specifically on the January 12, 2015 agenda, that no action could be taken, including sending a letter, and that the discussion was also inappropriate because it was not on the agenda. The City Attorney counselled that the item would need to be agendaized to proceed. When informed of this, Senior Commissioners expressed a sense of urgency to address the item, and requested that this special meeting be scheduled to review and approve a letter to the City Council about Self Help for the Elderly's services.

A draft letter has been provided as Attachment 1 for the Commission to review, discuss and edit/approve.
