- Introductions: Rick Bonilla, City Council Member Chair Yeatrakas introduced Council Member Rick Bonilla, who shared some of his background living in and serving the City of San Mateo.
- MINUTES APPROVAL

PUBLIC COMMENT

Commissioner Webb asked what was being done on the Senior Commission work plan. Chair Yeatrakas reported on the Villages work that is being done that includes San Mateo and announced information on that will be brought to the Commission at the July meeting. Pete Steele will report on the Livability Assessment and Senior Transportation items later at this meeting. Commissioner Webb shared a newspaper article on Foster City's Village and suggested that Foster City Village staff/volunteers are invited to the July meeting to report on their program. Chair Yeatrakas reported that after a feasibility study, Peninsula Family Services has decided not to move ahead as a hub for a Village program.

NEW BUSINESS

1. <u>City and County of San Francisco LGBT Task Force Report</u>

Commissioners were asked to discuss how the outcomes of the City and County of San Francisco LGBT Task Force Report might help the Senior Commission understand issues of aging for LGBT and general older adult population in San Mateo. Commissioners shared comments including that the housing issue is applicable but may be too much for the Senior Commission to take on. The Senior Commission can continue to advocate for senior housing including accessible housing in new developments. Council member Bonilla reported that the housing issue had been discussed at the City Council goal setting session, and he will bring this report to the attention of the City Council. Commissioner Lew would like to see cultural competency highlighted within each department of the City. Commissioners suggested revisiting the Aging Well report, comparing it with the San Francisco LGBT report, updating it with any changes needed and aligning it with a new Senior Commission work plan.

2. Commendatory Resolution- Melodie Lew

Chair Yeatrakas presented outgoing Commissioner Melodie Lew with Commendatory Resolution SR-1(2015), recognizing her for her 8 years of service on the Senior Commission. He thanked her on behalf of the Commission and staff and presented her with a gift.
