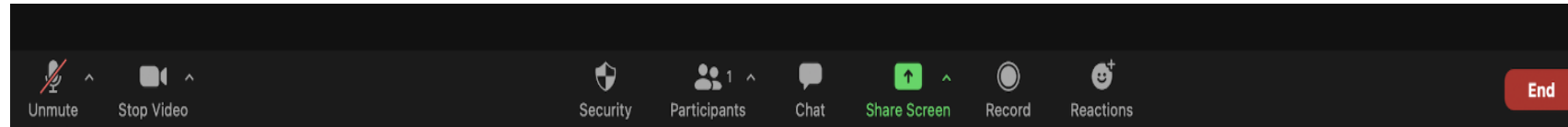

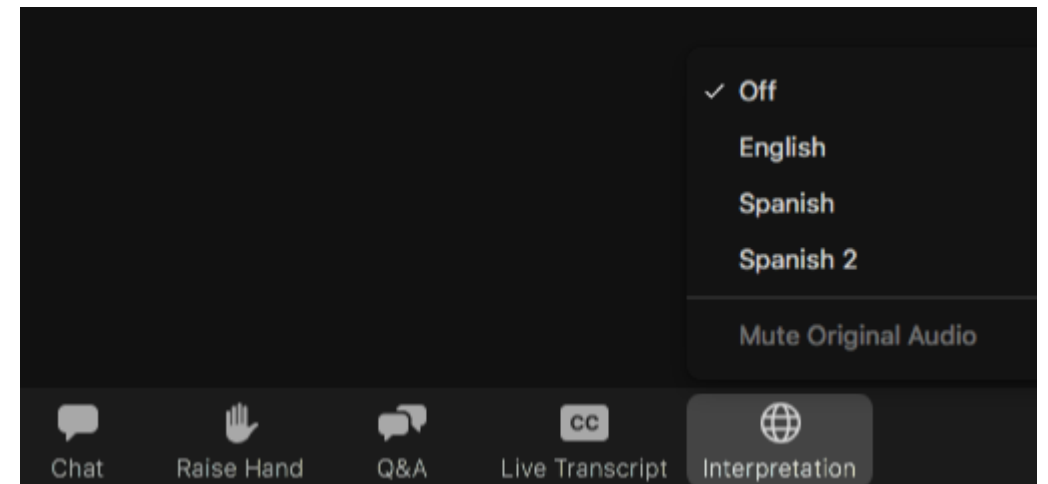

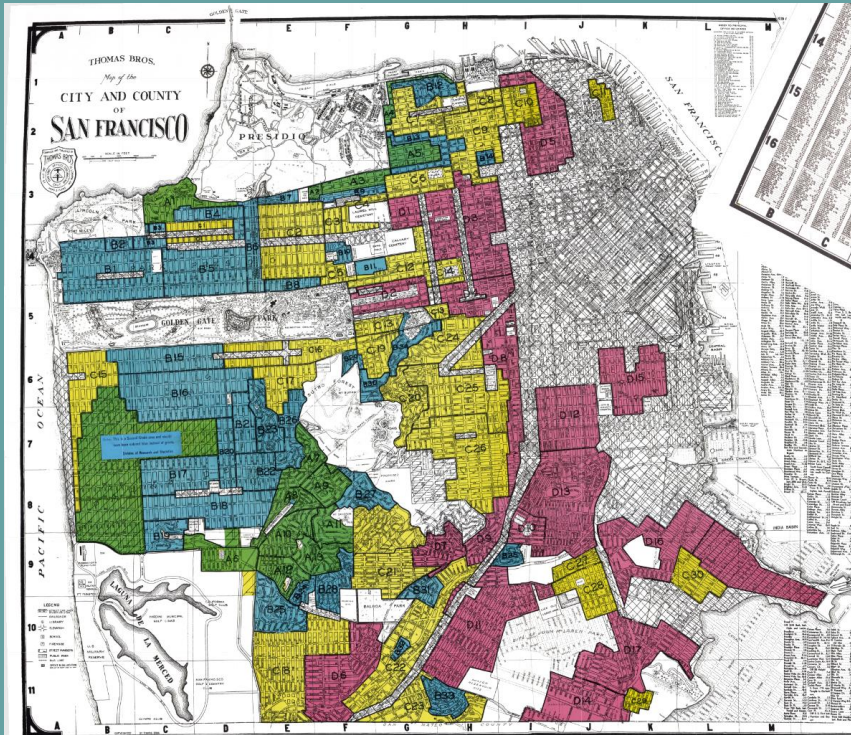

HOUSING ELEMENT

- Planning Period 2023-2031
- Capacity to accommodate RHNA -7,015
- Programs and Policies to support Housing at all income levels
- Programs and Policies to ensure inclusion of all residents (Fair Housing)

The Fair Housing Act (of 1968)

“Prohibited discrimination concerning the sale, rental, and financing of housing based on race, religion, national origin, sex, (and as amended) handicap and family status.”



Assembly Bill 686 (2018) defines Affirmatively Furthering Fair Housing (AFFH) as:

"taking meaningful actions, in addition to combating discrimination, that overcome patterns of segregation and foster inclusive communities free from barriers that restrict access to opportunity based on protected characteristics".

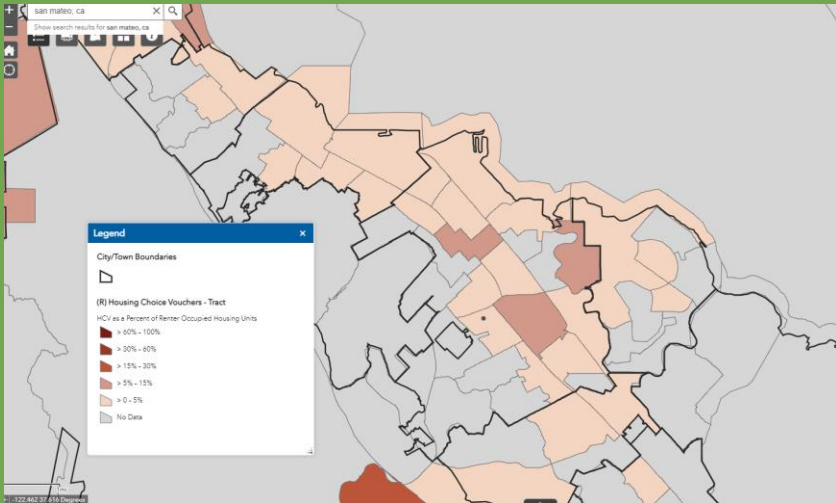

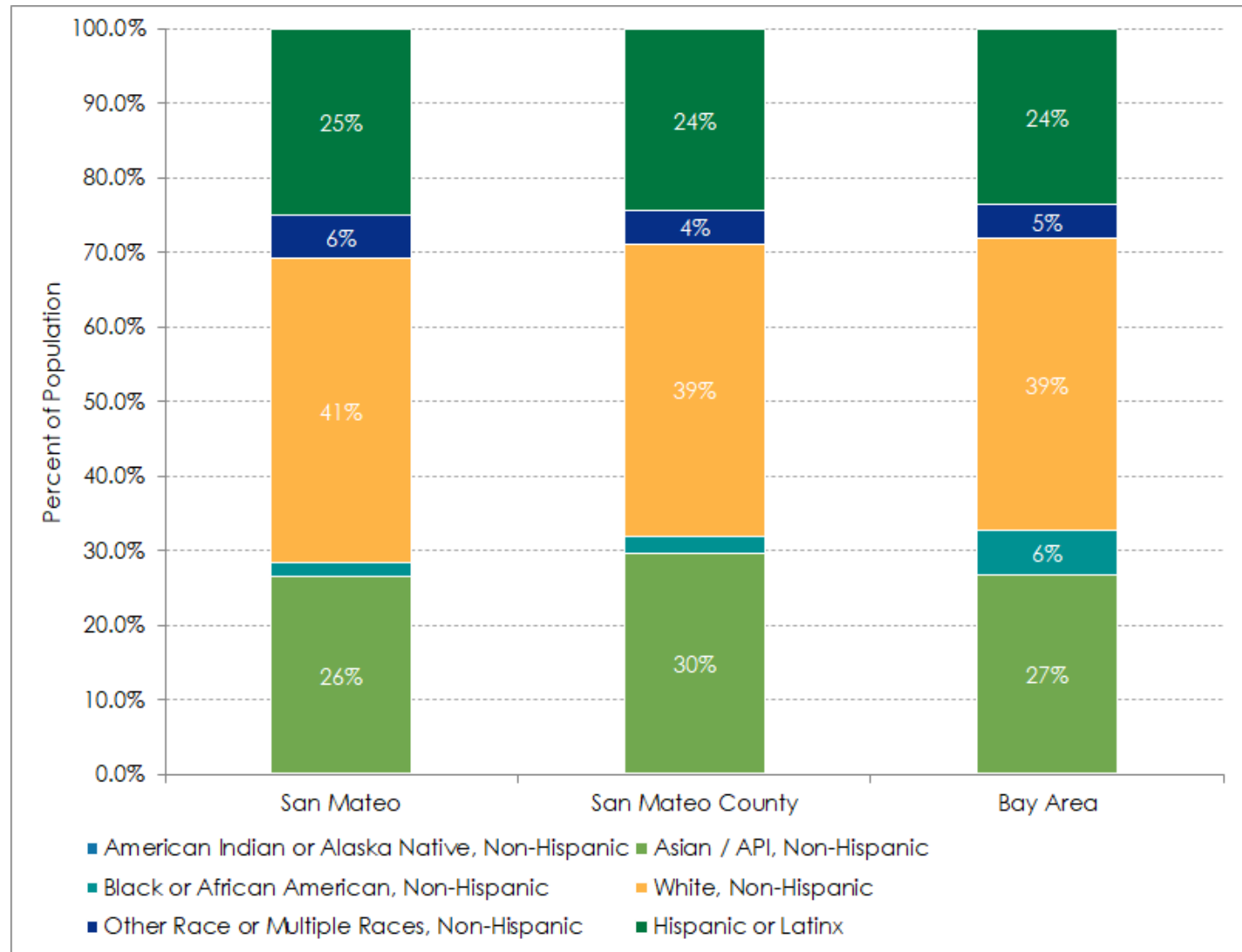


Assessment of Fair Housing (AFH)

- We must include in our housing element update and assessment of:
 1. Fair Housing Outreach and Enforcement
 2. Segregation and Integration Patterns
 3. Disparities in Access to Opportunity
 4. Disproportionate Housing Need and Displacement
 5. Racially and Ethnically Concentrated Areas of Poverty (RE/CAP)

San Mateo Key Facts



Assessment of Fair Housing

Racial and ethnic minorities are disproportionately impacted by :

- Higher poverty
- Lower household income
- Higher overcrowding
- More homelessness



Assessment of Fair Housing

San Mateo Key Facts

- Almost half of renters are **cost burdened** (30% - 50% of income)
- A quarter are **extremely cost burdened** (50%+ of income)

Further disparities:

- Renters versus Owners
- Black and Hispanic households
- Large families

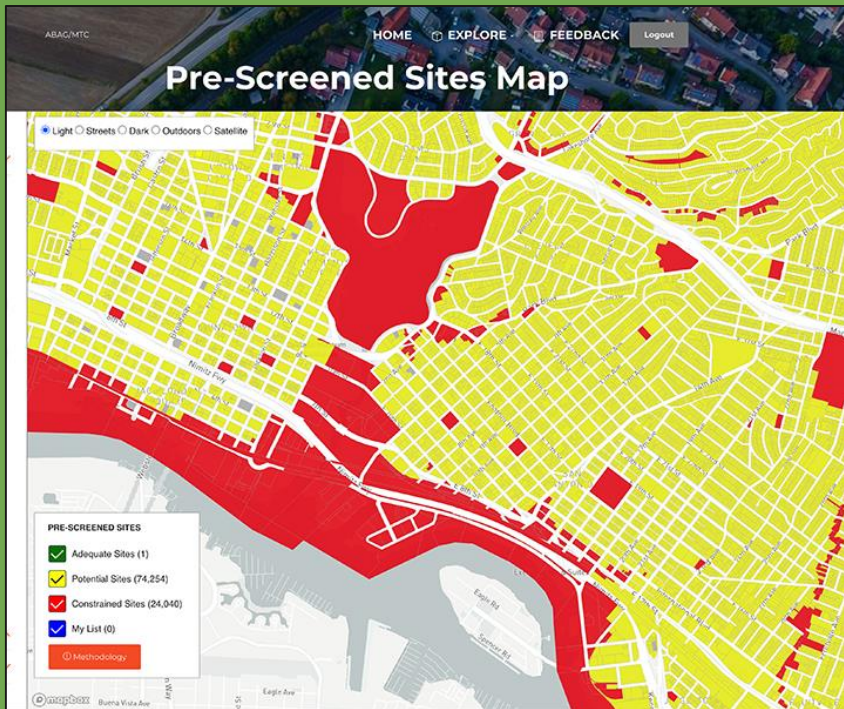


Assessment of Fair Housing

Special Needs -Residents with Disabilities

- 9% of population
- Experience higher unemployment

New Housing Element Requirements



Sites Inventory

- Contribute toward replacing segregated living patterns with truly integrated and balanced living patterns
- Transform high poverty neighborhoods into areas of opportunity

New Housing Element Requirements



ID and Prioritize Contributing Factors

- Determine factors contributing to the creation and perpetuation of fair housing issues
 - community opposition to development
 - exclusionary zoning codes
 - lack of funding and resources

New Housing Element Requirements



Goals, Policies & Actions

Policies and actions can vary widely, depending on the fair housing issues identified, e.g.:

- Few housing choices → increasing density, ADU policies, etc.
- High displacement rates/risk → tenant protections, rental assistance, etc.
- No subsidized housing → policies to increase funding, housing trust funds, public land disposition, etc.
- Affordable housing applicants don't match demographics of residents → targeted outreach programs

From Service Providers:

Vulnerable populations include:

- People w/disabilities(accessibility)/racial bias
- No fault evictions: high impact on Hispanic/Black households; households w/children
- Extremely low-income households

Assessment of Fair Housing

From Community Members:

“We love that we have many kinds of neighbors, socio-economically. We hope that can continue”

“San Mateo is not a place for low-income families”

“Two stories [second floor walkup apartment] are bad because my legs are hurt.”

“I'm a renter and ... I love the area so much. I cannot afford another rent hike. The next one will probably force me to move away. Please...keep renters in mind.”

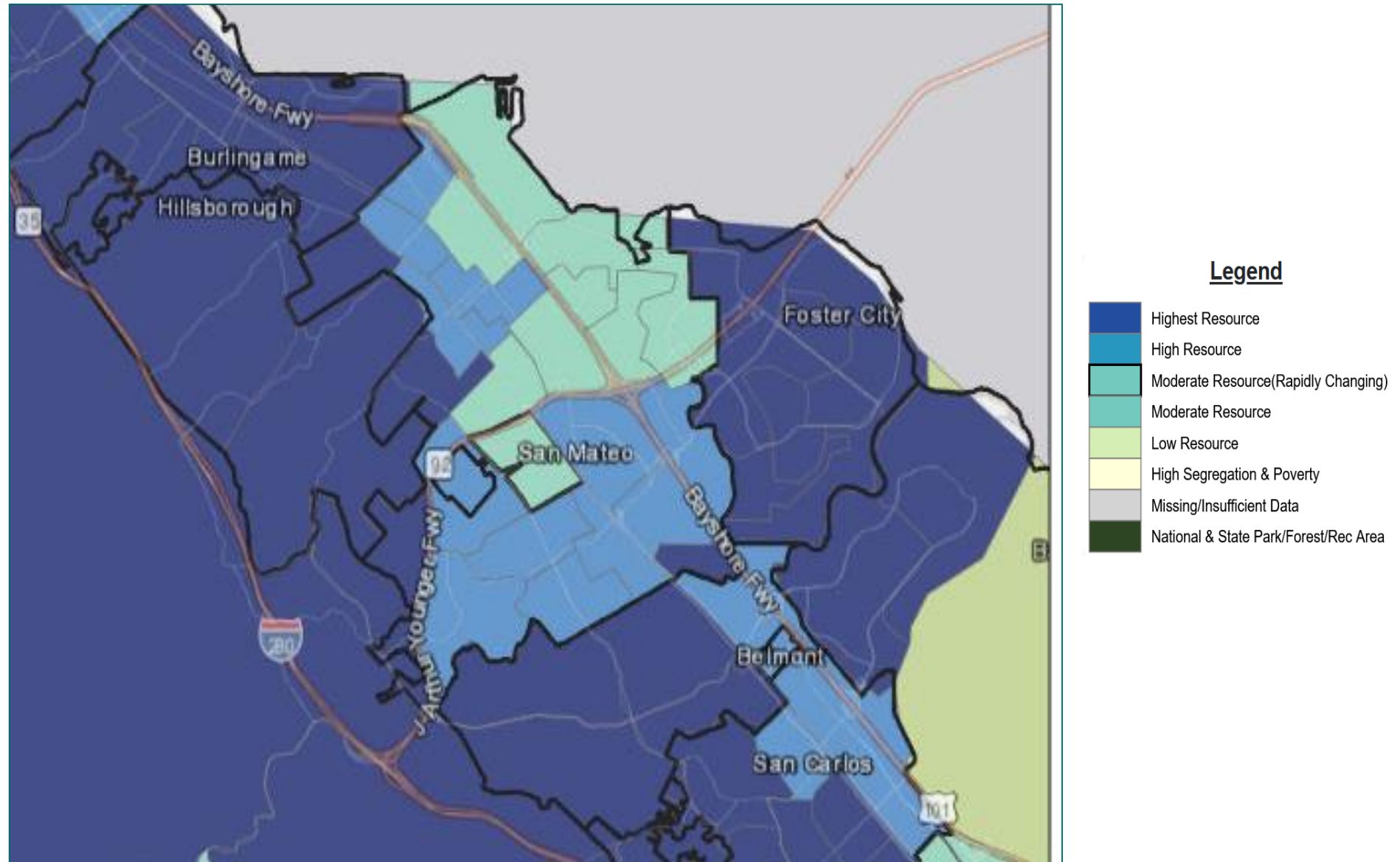

Racial Dot Map of San Mateo



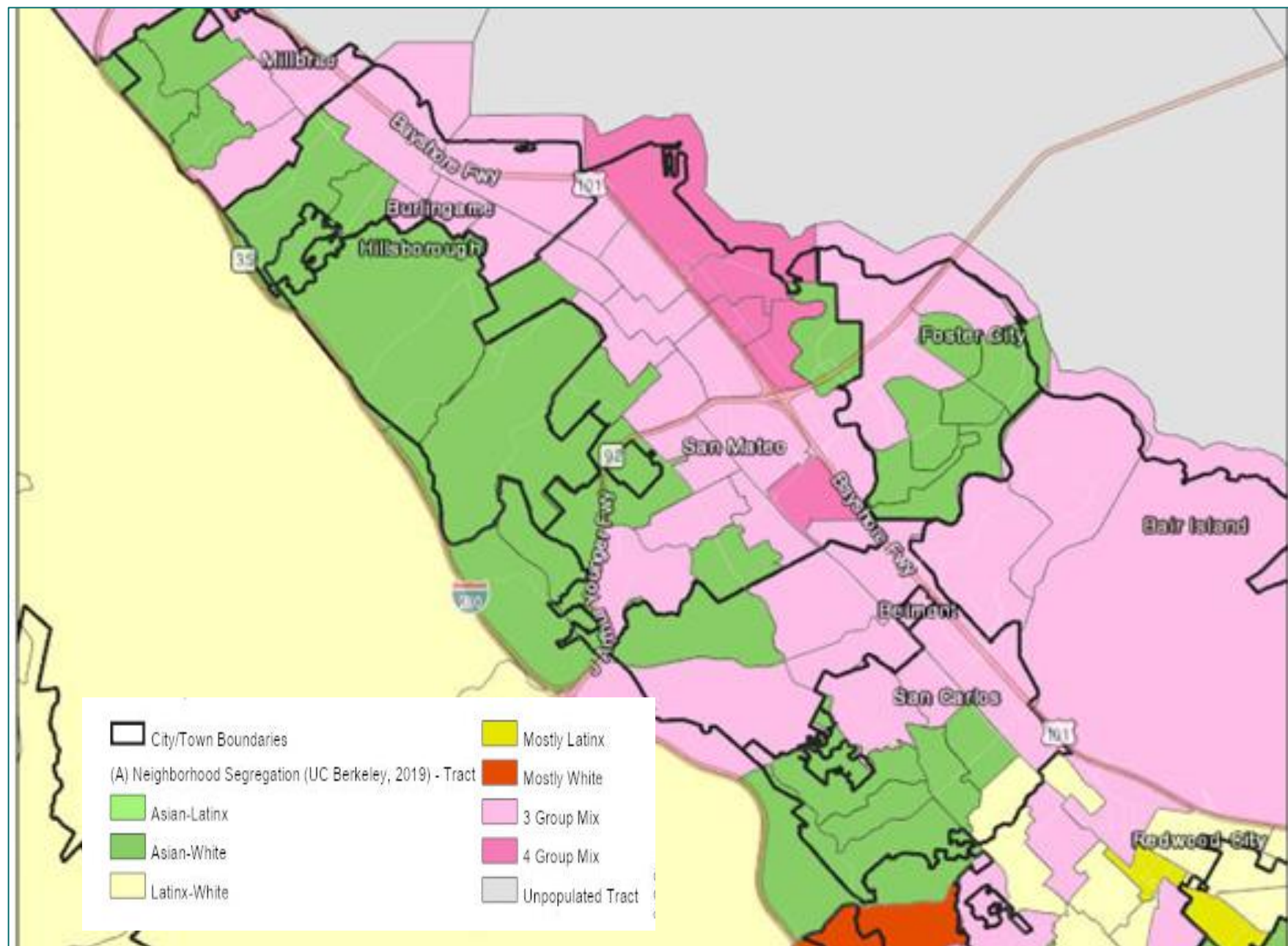
Race and Ethnicity by census block - Race and Ethnicity by census block

- Ensure affordable housing opportunities are created throughout the entire city

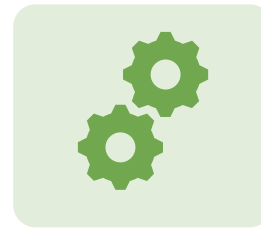

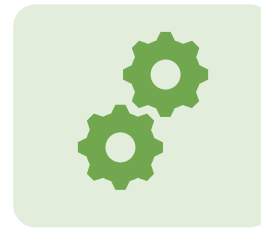
